## ACKNOWLEDGMENT OF RISK AND RELEASE OF LIABILITY

## Every Person Must Read and Understand this Waiver Before Participating in the Animal & Nature-Assisted Activities

The following waiver of all claims, release from all liability, assumption of all risks, agreement not to sue and other terms of this agreement are entered into by me (the Participant) with and for the benefit of HillBilly Resort Inc.™ Animal & Nature Assisted Therapy a.k.a HillBilly Hiking, agree to release, indemnify, defend, and hold harmless the officers, members, managers, employees, business operators, agents, tenants, site-property owners or leasees, guests and invitees of each group, from and against any form of loss, cost, damage, injury, and/or any other claim resulting from or occasioned by (i) my participation in or instructional training provided at the HillBilly Resort Inc. classes, health programs or workshops held at 19-19-3E SW ("Land and Buildings"), and (ii) my presence at and/or use and occupation of the land and buildings. Without limiting the generality of the foregoing, "Animal and Nature Activities" include but are not limited to interacting with large animals including wildlife, being in a nature environment, nature walks, skating, tobogganing, nature crafting or building in nature, provided by the "Host" to the Participant.

I am aware that there are inherent dangers, hazards, and risks associated with animal and nature activities and injuries resulting from these "Risks" can occur. I am aware that the risks of animal and nature activities mean those dangerous conditions which are an integral part of animal and nature activities, including but not limited to:

- \_\_\_\_\_(b) the unpredictability of ruminant, canine, feline or fowl's reaction to such things as sounds, sudden movement, tremors, vibrations, unfamiliar objects, persons or other animals and hazards such as subsurface objects.
- \_\_\_\_(c) the potential for other participants to behave in a negligent manner that may contribute to injury to themselves or others, including failing to act within their abilities to maintain control over the ruminant, canine, feline or fowl; and
- \_\_\_\_\_(d) the potential for participants to fall over or from obstacles, from animals & nature, or from moving vehicles that may be found in a nature setting.
- \_\_\_\_(e) the potential to be at greater risk of illness or infection while participating in an outdoor

setting or with any ruminant, canine, feline, or fowl, particularly for person with auto-immune deficiencies.
(f) the potential to be at greater risk of illness or infection while participating with animals
while pregnant. (g) the potential for wildlife encounters and the unpredictable nature of such animals. (h)I further agree to release, indemnify, defend, and hold harmless the members, managers, employees, agents, tenants, guests and invitees of each group, from and against any loss, cost, damage, injury, and/or any other claim resulting from or occasioned by  (i) my participation in or instructional training provided at the HillBilly Resort Inc. classes, health programs or workshops held at 19-19-3E SW ("Land and Buildings"), and  (ii) my presence at and/or use and occupation of the land and buildings.
